



# EXAMPLES

## TEMPORARY POLE PERMIT

\$ 6.00 (1-CIRCUIT) (\$6.00 PER CIRCUIT UP TO 10)  
\$ 10.00 (TEMPORARY)  
\$ 40.00 (APPLICATION FEE)  
\$ 56.00 (SUBTOTAL)  
\$ 1.00 (1% STATE FEE) (ROUNDED UP TO NEXT DOLLAR)  
**\$ 57.00 TOTAL FEE**

## NEW HOUSE EXAMPLE

\$ 15.00 (AT 200 AMP)  
\$ 60.00 (EXAMPLE 10 CIRCUITS (\$6.00 EACH 1-10 CIRCUITS))  
\$ 75.00 (EXAMPLE 25 CIRCUITS (\$3.00 EACH ADDITIONAL CIRCUIT ABOVE 10))  
\$ 40.00 (APPLICATION FEE)  
\$190.00 (SUBTOTAL) \$190.00 X1%= \$1.90 (ROUND UP TO NEXT DOLLAR= \$2.00)  
\$ 2.00 (1% STATE FEE) (ROUNDED UP TO NEXT DOLLAR)  
**\$192.00 TOTAL FEE**

## ADDITIONS EXAMPLE

\$ 10.00 (ALTERATIONS/ADD-ONS)  
\$ 18.00 (EXAMPLE 3 ADDITIONAL CIRCUITS (\$6.00 EACH CIRCUIT))  
\$ 40.00 (APPLICATION FEE)  
\$ 68.00 (SUBTOTAL) \$68.00X1%= \$.68 (ROUND UP TO NEXT DOLLAR = \$1.00)  
\$ 1.00 (1% STATE FEE) (ROUNDED UP TO NEXT DOLLAR)  
**\$ 69.00 TOTAL FEE**

## POOL BONDING EXAMPLE

\$ 6.00 (FOR ONE CIRCUIT) (EACH CIRCUIT 1-10 IS \$6.00 EACH)  
\$20.00 (POOL BONDING-OTHER)  
\$40.00 (APPLICATION)  
\$66.00 (SUBTOTAL) 66.00 X 1%= \$.66 (ROUND UP TO NEXT DOLLAR = \$1.00)  
\$ 1.00 (1% STATE FEE) (ROUNDED UP TO NEXT DOLLAR)  
**\$67.00 TOTAL FEE**

## TO REGISTER WE REQUIRE:

1. COPY OF LIABILITY INSURANCE CERTIFICATE SHOWING COVERAGE (MINIMUM COVERAGE \$100,000/300,000 - BODILY INJURY / \$25,000 PROPERTY DAMAGE.
2. IF ANY EMPLOYEES, SUBMIT A COPY OF CURRENT WORKERS COMPENSATION CERTIFICATE.
3. \$200.00 REGISTRATION FEE. \$100.00 RENEWAL FEE.
